I used the PowerSpin drain snake to clear the tubdrain blockage. The snake ran into resistance that felt like a hard object of some sort. I ran a camera down the drain but could see no obstruction(the camera would only go to the bottom of the P-trap, it could not make the P-trap bend).

## TECHNICIAN RECOMMENDATIONS:

I recommended replacing the tub drain as it is deteriorating quite badly.
