REASON FOR TODAY'S CALL:

1)Remove broken garburator, replace with standard plumbing pipes. 2)Clear slow draining bathtub drain.

DESCRIPTION OF WORK PERFORMED:

-I removed the garburator, installed a basket strainer in it?s place, and repiped the ABS drainage. Tested by filling and draining both sides of the sink multiple times. -I used the PowerSpin drain snake to clean the tub drain.

TECHNICIAN RECOMMENDATIONS:

-During testing of the sink I noticed the kitchen faucet is leaking from under the handle when lifted all the way up(fully open position). This is likely an issue with the cartridge but given the age of the faucet I would recomend replacement over repair.
