REASON FOR TODAY'S CALL:

Leaking bathroom faucet.

DESCRIPTION OF WORK PERFORMED:

The leak was coming from under the handle when in use. I removed the handle and found that the nut securing the cartridge in place was loose. I tightened this nut and tested. No other leaks were detected.

TECHNICIAN RECOMMENDATIONS:

I noticed during testing that the cold supply line(integral to the faucet) was kinked. While this would have happened during initial installation, which was likely a very long time ago, this type of kink poses a high likelihood of creating a leak. I suggested replacement but the owners decided not to go ahead with my suggestion.
