REASON FOR TODAY'S CALL:

1. The head of kitchen faucet is cracked leading to water spill. 2. There is a notice in the building to replace shower cartridge. I believe I did get it replaced by yourself not sure if it is required but the tenant felt water was an issue.

DESCRIPTION OF WORK PERFORMED:

The shut off valves under the kitchen sink(connected to the faucet) were not working. I located the main water shut off valves, turned the water off to the valves, and repaired them by replacing the washers, stems, packing, packing nuts, and handles. I then installed the new kitchen faucet and tested. *I showed Peter where the main shut off valves were located and how to use them in case of an emergency.

TECHNICIAN RECOMMENDATIONS:

Unfortunately I do not have any of the PBR40 cartridges for the shower valve left in stock but they are on order and I will contact the tenant as soon as they arrive.
