**DESCRIPTION OF WORK PERFORMED:**

Jan26: I made a visit with Jeff Dos Santos and Jim Leung, we tried to attached the trim exactly flush with teh wall but were unsuccessful. we all ran out of time so I agreed to return the next day and figure it out. --Jan27: I made a trip to the unit on Saturday and figured out a way to secure the handle trims tight to the finished wall by using little wedges I made from copper strapping to eliminate the gap between the handle trim and the circular brass ring it attaches to. However, I was unable to recalibrate the thermostatic cartridge because shortly after turning on the rain shower I noticed a small drip coming from the rough-in valve. I immediately turned the rain shower off and closed the integral stops. The plumber that originally installed the valve will be notified.
