REASON FOR TODAY'S CALL:

Our kitchen garburator has been leaking. This has gone on for quite some time and we have just stopped using it. We try not to let water go down that sink and use the other one (we have a double sink in kitchen). Garburator likely needs to be replaced *take look at toilet. slow flushing.

DESCRIPTION OF WORK PERFORMED:

-I replaced the garburator with a new Badger5 and tested by filling and draining the sink multiple times while running the garburator. -I took a look at the toilet in question and found that the water level in the tank was low. I raised the water level in the tank and the flush was better but I could not get the water level high enough as the fillvalve was malfunctioning. The fillvalve was also taking longer than normal to fill the tank after each flush. I replaced the FillValve and supply line and tested, the flush is now much stronger.
