## REASON FOR TODAY'S CALL:

Hi! My Delta touch faucet has stopped working (no water flow - I think its the solenoid). Is there a way to decommission the "touch" part so that I can just use it as a regular faucet or should I buy a regular replacement faucet for you to install. I have tried disconnecting the batteries and solenoid and the water still doesn't run I am also wanting to get my shower handle checked - its stiff to turn and almost feels like some flex piping is tangled with it. Last week it was nice and loose, this week not so much!! Pictures of both things are attached.

## DESCRIPTION OF WORK PERFORMED:

-Unfortunately the touch feature on the guest bathroom lavatory faucet could not be bypassed. I installed the new customer supplied faucet and mechanical drain. Tested by filling and draining the sink multipl times. -The Handle in the master ensuite tub/shower was stiff to turn side to side. I replaced the cartridge within the valve and tested. It is now functioning normally.
